
- Do not touch LED when fixture is turned on. Do not look directly at lit LED.

Pre-assembly:


- Remove all parts and hardware from box along with any plastic protective packaging.
- Do not discard any contents until after assembly is complete to avoid accidentally discarding small parts or hardware.

- (A) Switch (1)
- (B) Plug (1)




TO USE:



Gently rotate the light rod to horizontal position as shown.
 Insert the Plug (B) into a proper socket. Rotate the Switch
 (A) to turn on & adjust the brightness of the light.

2. Place a compatible mobile device in the center of the charging plate located on the lamp base.

Note: Maximum output: 12V/1A.

- This wireless charger supports with Qi-Certified devices only.
